Gwinnett County Environmental Health Body Artist Training

The Gwinnett County Body Art Regulations require that all body artists must have up-to-date training in the following topics:

- 1. Blood-borne pathogens
- 2. Sterilization (running an autoclave)
- 3. First Aid
- 4. CPR
- 5. Sanitary Procedures

To earn course credit in one of these topics, the course certificate must either state the topic or other adequate documentation from the training organization must be submitted. Other adequate documentation is a course syllabus or a letter from the training organization stating the topic was covered in the course. Trainings cannot be older than two years. Also, if the training organization has a renewal requirement on the certificate of less than two years, we must honor that requirement. **Documentation of passing a course must be submitted to Gwinnett Environmental Health.**

The following courses have been approved to cover blood-borne pathogens, sterilization and sanitary procedures. First Aid and CPR will need to be taken separately.
