Job Summary: Under supervision, will participate in a clinical role at Health Department COVID mass vaccination/specimen collection sites. Duties may include: vaccinating, patient education, patient observation, response to vaccine adverse events, site set-up/break down, field response vaccinations and other roles to support COVID operations. Administration sites may include mass vaccination site, Health Department clinics, mobile clinics, community facilities, and patient's homes Must be prepared to assist with handling minor emergencies related to vaccinations including allergies, anaphylaxis, and respiratory difficulty.

Job Requirements: May be assigned to work OUTSIDE and MUST have the ability to be on your feet for 8+ hours. Part time employees must be flexible with working schedule & be required to work a minimum of 16-24 hours per week. Full time employees must work 40 hours per week. Operational hours may include Monday-Sunday 7:00am-8:00pm & may work COVID operations in Gwinnett, Newton or Rockdale Counties. This is a Temporary COVID Response position. Continuation dependent on COVID funding.
