Dear COVID-19 Therapeutics Provider:

In response to the recently announced Health and Human Services (HHS) monoclonal antibody (mAb) ordering requirements, the Georgia Department of Public Health (DPH) has developed an ordering process for mAb providers.

Georgia will receive the state's allocation numbers from Health and Human Services (HHS) every Tuesday afternoon. **Providers will be expected to place their requests by noon on Wednesdays to be considered in that week's allocations.** Hospitals are required to report the previous week's usage and current inventory via WebEOC. Other providers are required to report their inventory and usage via a TeleTracking account. If assistance is needed to obtain an account, please send an e-mail to hhs-protect@teletracking.com.

All requests must be submitted by 12 p.m. (noon) on Wednesdays through https://ga.readyop.com/fs/59Dp/dfe9.

Equitable allocations will be made based on factors including but not limited to utilization rates, on-hand inventory, and storage capacity. DPH will then place orders with AmerisourceBergen for shipment directly to providers. AmerisourceBergen says they will ship orders the following week and will provide shipping information, including number of doses being shipped, directly to the point of contact placing the order. Please ensure your internal communications are aligned so you can appropriately prepare your clinics for the arrival of shipments of products.

Important Reminders

- Providers will need their AmerisourceBergen account number to place a request. If you are not currently enrolled, please email covid19-therapeutics@dph.ga.gov for enrollment information. If you have completed your enrollment and are waiting for your mAb account number, you may insert TBD into field of the order form.
- Providers should be using at least 70% of their allocation within 7 days of receiving the supplies.
- Providers are required to report their usage as described above each week to receive an allocation.
- Order requests must be placed by 12 p.m. (noon) on Wednesdays to be considered for that week's allocation.
- The minimum request for REGEN-COV is 12 courses and the maximum request is 240 courses.
- The minimum request for Bam/Ete is 50 courses and the maximum request is 200 courses.

Providers should plan appointments around their current inventory, not requested inventory. While Regen-COV and Bam/Ete are available in limited quantities through HHS allocation to Georgia at no cost, providers can also look into purchasing Sotrovimab directly through GSK (https://sotrovimab.com/hcp/access).

The enrollment of new providers will be regularly reassessed to adjust to changes in state allocations, inventory, and geographic distribution to ensure equitable access to mAbs.
