Gwinnett, Newton and Rockdale County Health Departments is seeking a qualified nurse practitioner (NP) to provide clinical services in our Public Health clinics and/or Mobile Clinical Unit. The incumbent will provide specialized nursing care primarily in our family planning and women's health programs. The incumbent will function under a Public Health nurse protocols, primarily identifying and providing family planning services including inserting and removing long acting contraceptives. The NP will work collaboratively with a multidisciplinary Public Health clinical team to optimize patient care and meet organizational needs. The NP will also provide guidance and support to RNs, LPNs and MAs, and may support other clinical program needs based on training and licensure. **Positions will be filled as full time or hourly. Hourly positions may only work up to 29 hours per week & are not eligible for benefits below.**
