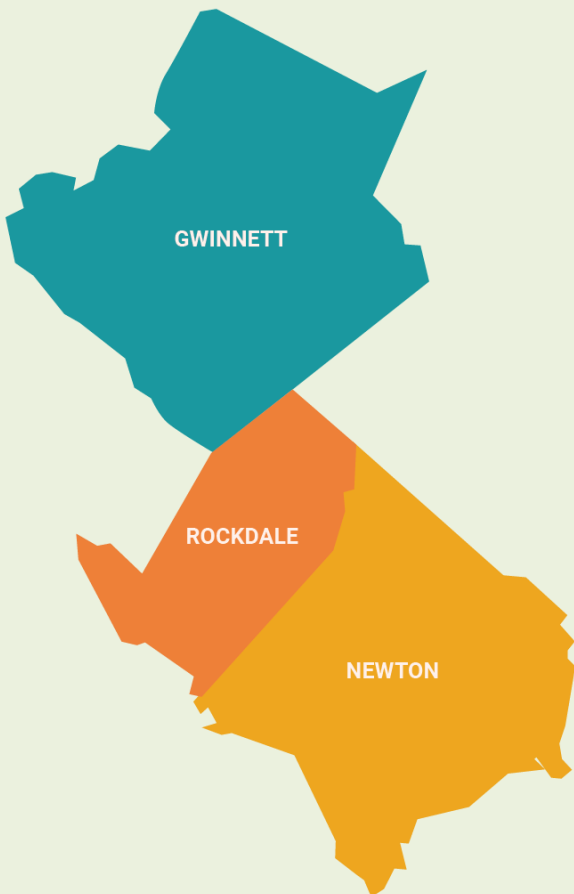


# COVID-19 Morbidity and Mortality Report

# COVID-19 District Overview

The information presented on this page describes the COVID-19 disease burden across the three-county Health District. Data displayed on this page represents both cumulative (from the beginning of the pandemic to the present) and specified time frames. The headers will indicate if the information is cumulative.

## Gwinnett County

There was a **59% decrease** in reported cases this current 4 week reporting period (2/27 – 3/30) compared to the previous 4 week reporting period (2/2 – 3/1).

## Newton County

There was a **49% decrease** in reported cases this current 4 week reporting period (2/27 – 3/30) compared to the previous 4 week reporting period (2/2 – 3/1).

## Rockdale County

There was a **59% decrease** in reported cases this current 4 week reporting period (2/27 – 3/30) compared to the previous 4 week reporting period (2/2 – 3/1).

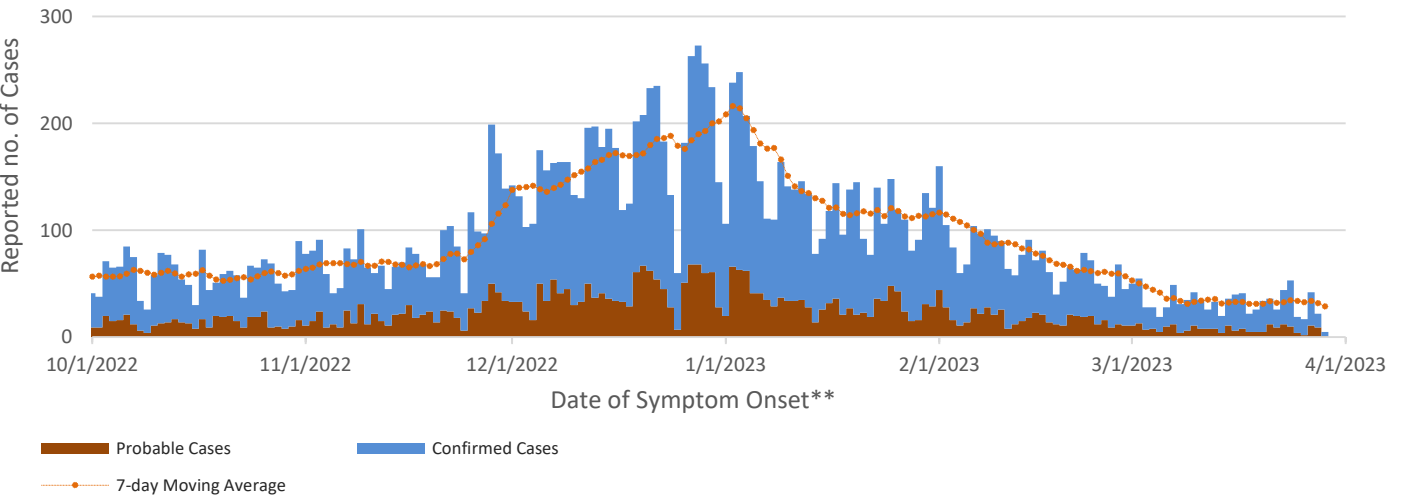
### CDC Community Indicators

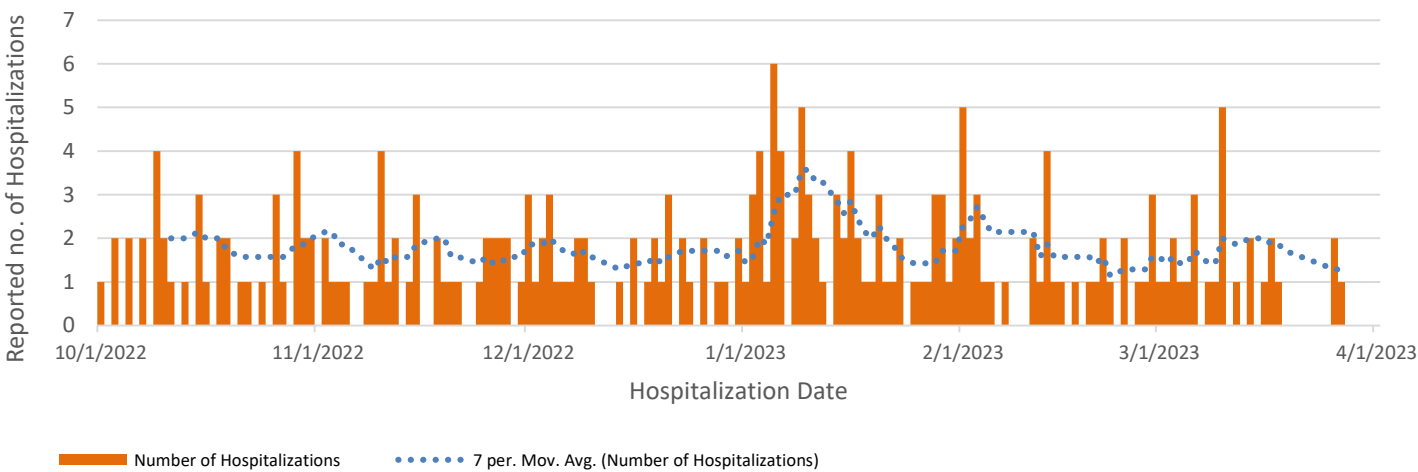
The data displayed on this page represents the number of all cause hospitalizations by hospitalization date among COVID-19 cases residing in the district, and the number of COVID-19 related deaths by date of death of COVID-19 cases who resided in the district. Case totals include confirmed and probable cases.

All cause hospitalizations means that the COVID-19 case was reported as being hospitalized, but that hospitalization may not be directly attributable to their COVID-19 illness. For example, and individual is hospitalized to give birth, and at the time that patient is admitted, they test positive for COVID-19.

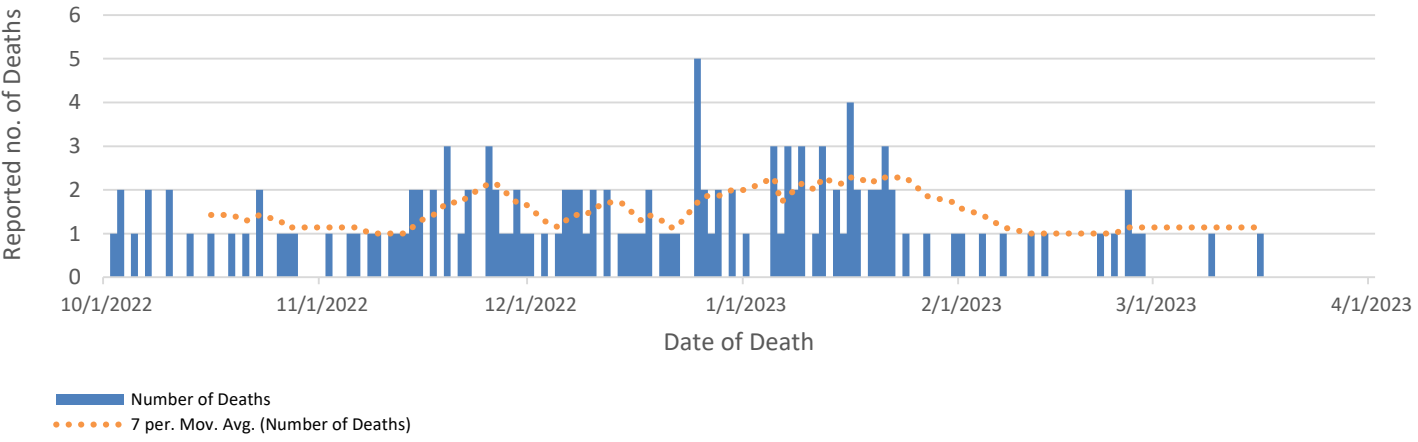

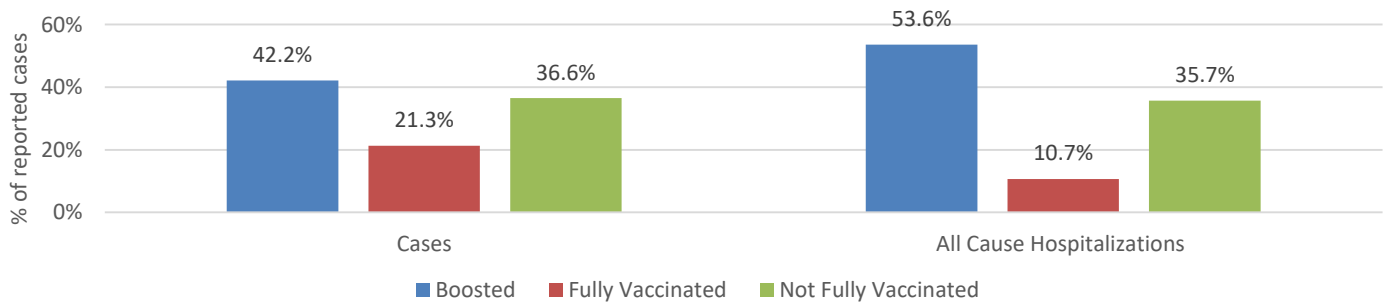

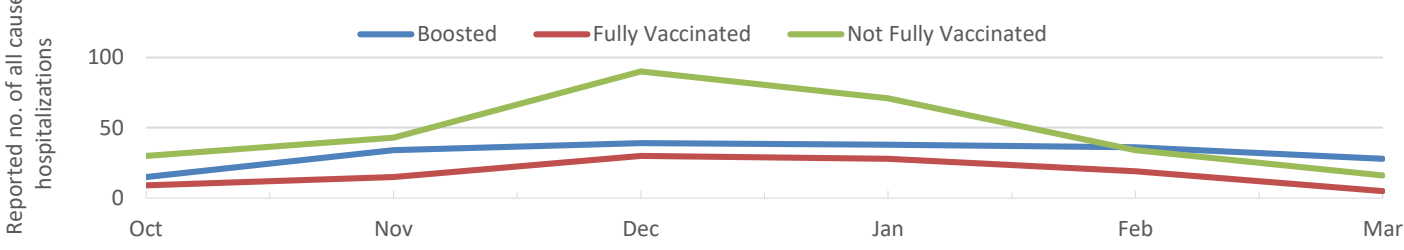

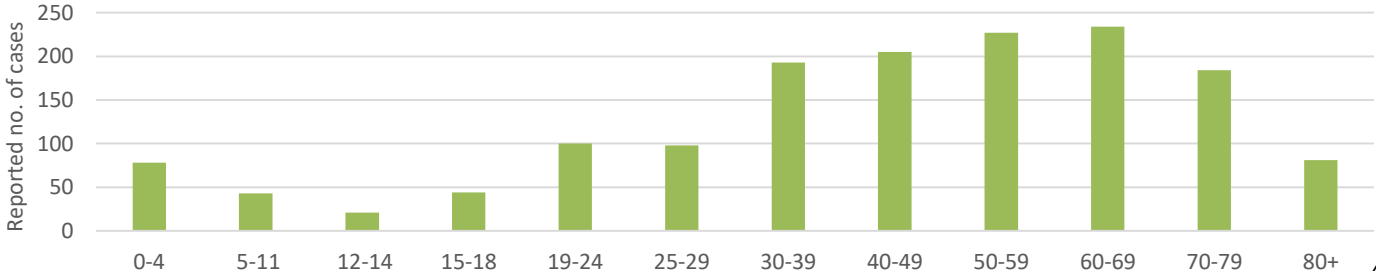

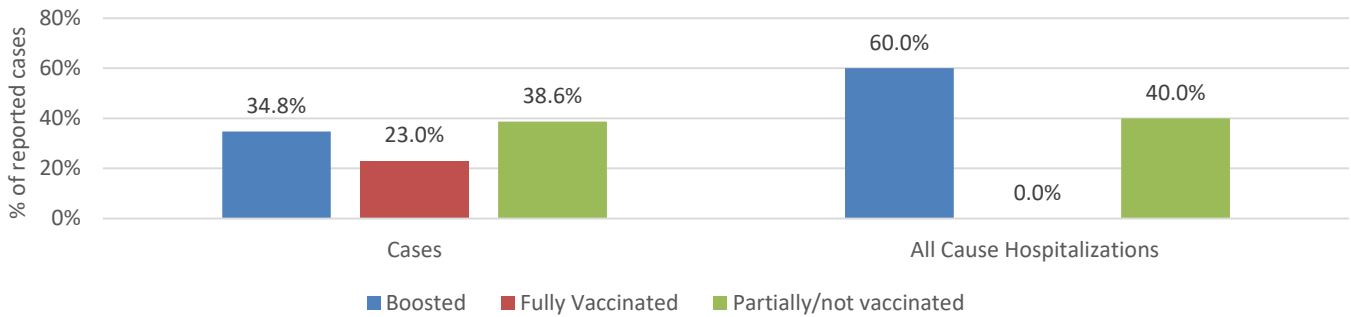

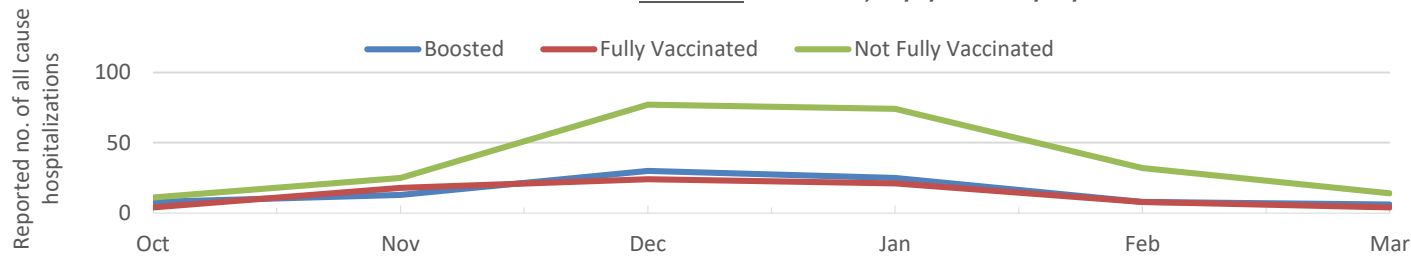

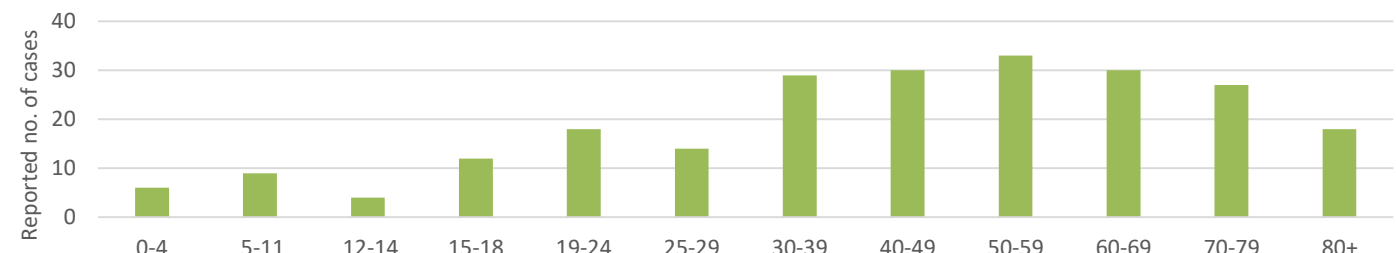

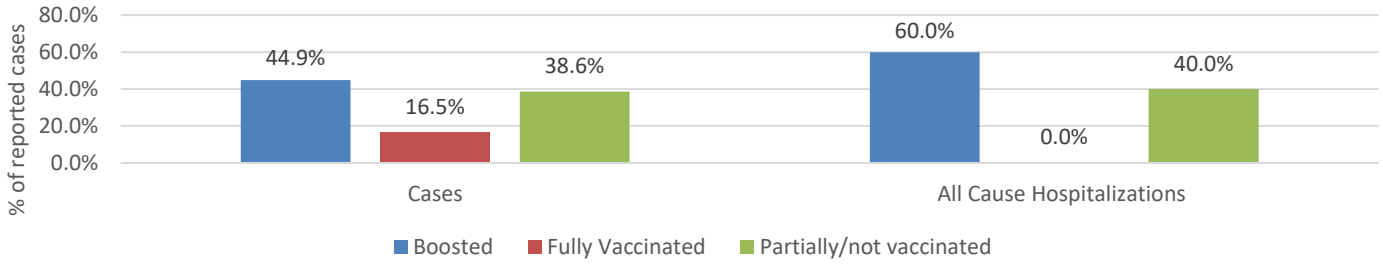

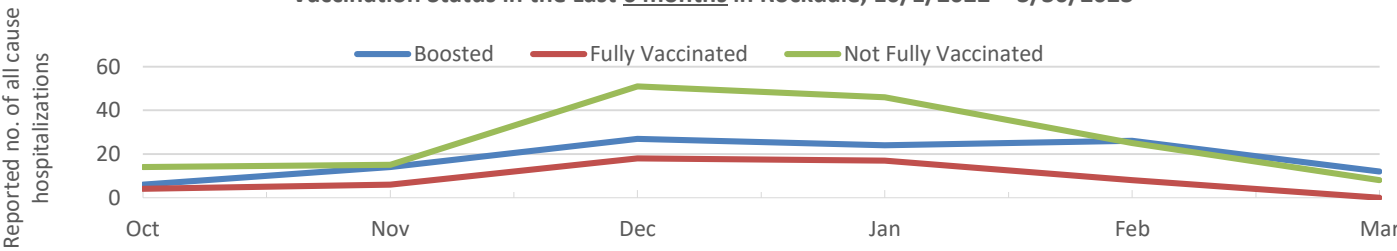

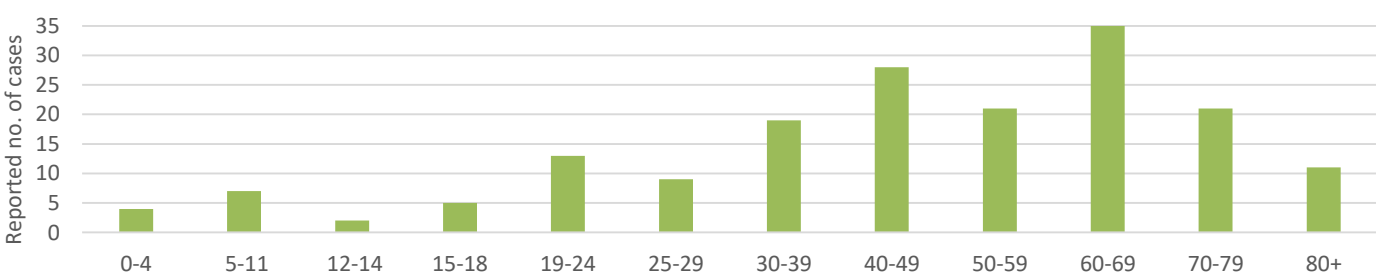

# COVID-19 Outbreaks



**District Residents,** *data as 8 am March 31, 2023*

All three counties within the district are experiencing outbreaks of COVID-19. The information below is intended to provide information on where outbreaks are occurring within the district by county.

If a county or a certain facility type is not displayed in the number of outbreaks reported in the last 30 days graph that means that there were no outbreaks reported in the 30 day period for that county or facility type.

A COVID-19 outbreak is generally\* defined as 2 or more COVID-19 cases that occur within 14-days of each other in a given setting. In some higher risk settings (such as long-term care facilities, and jails/prisons) 1 COVID-19 case in that setting is considered an outbreak. An outbreak is considered over when 28-days have passed without a case at that facility/setting.

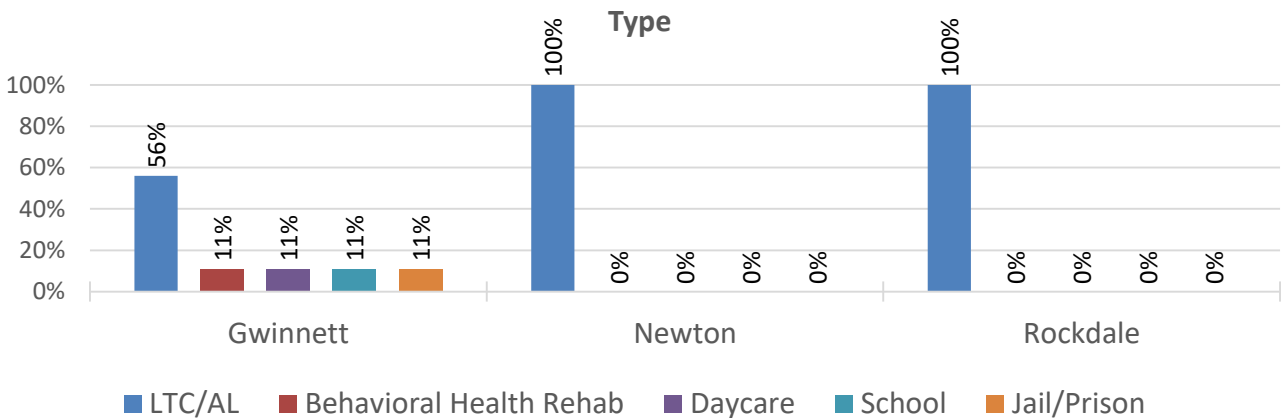

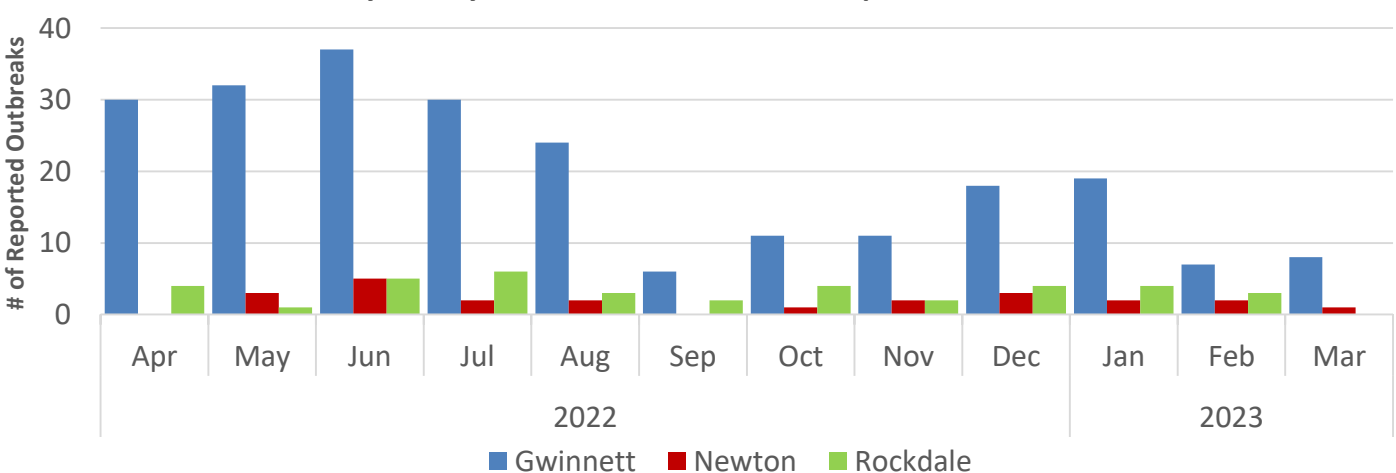

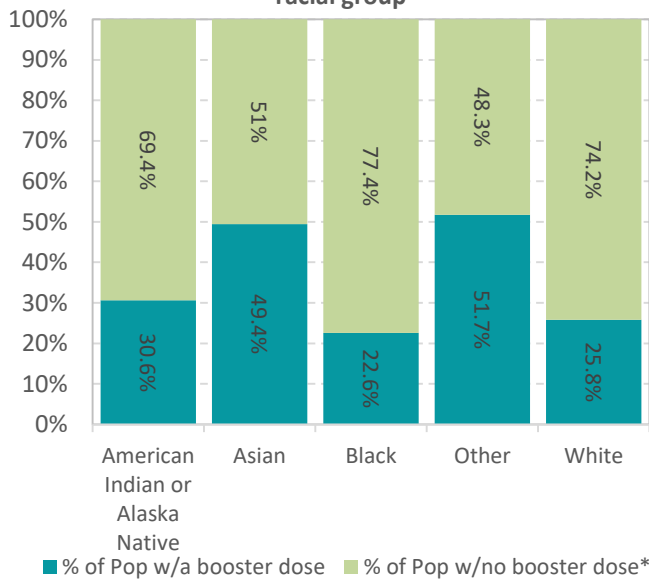

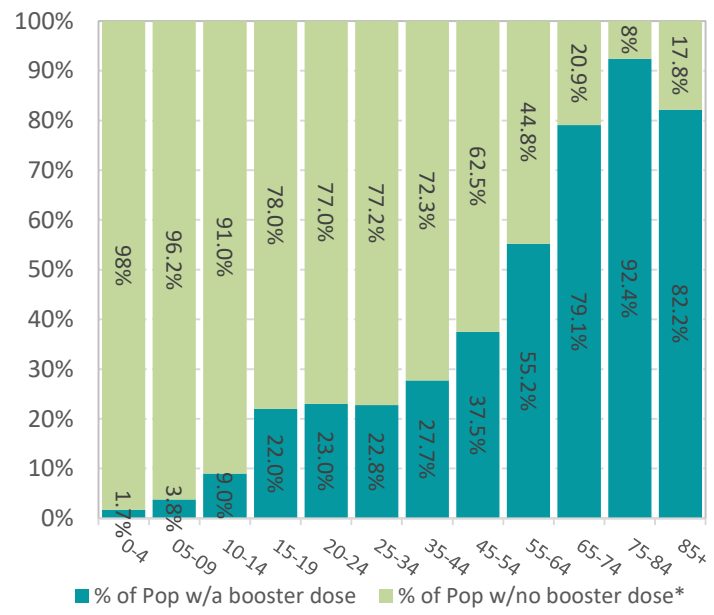

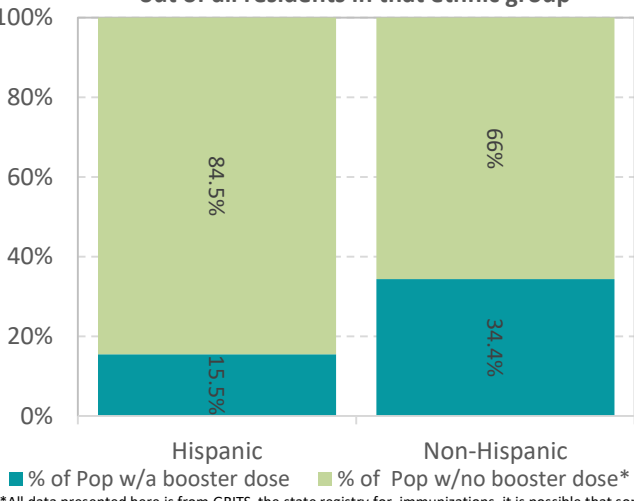

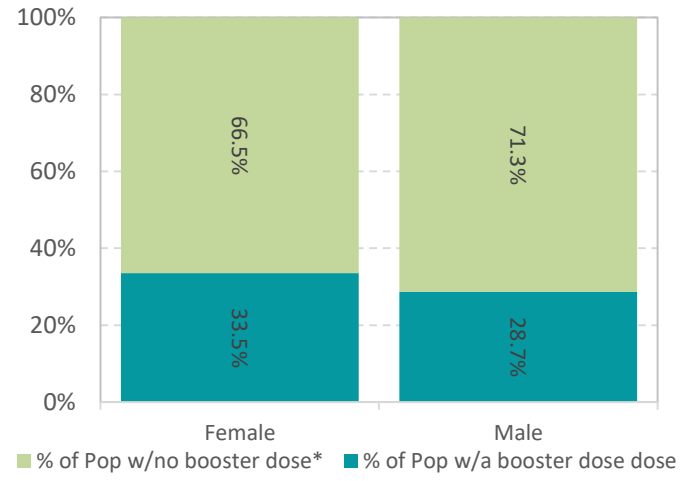
**% of Gwinnett residents who have received a booster dose by age group out of all residents in that age group**

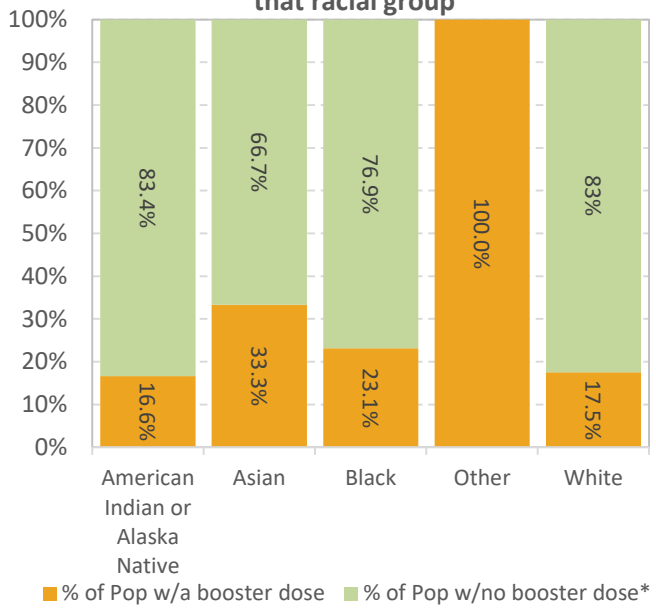

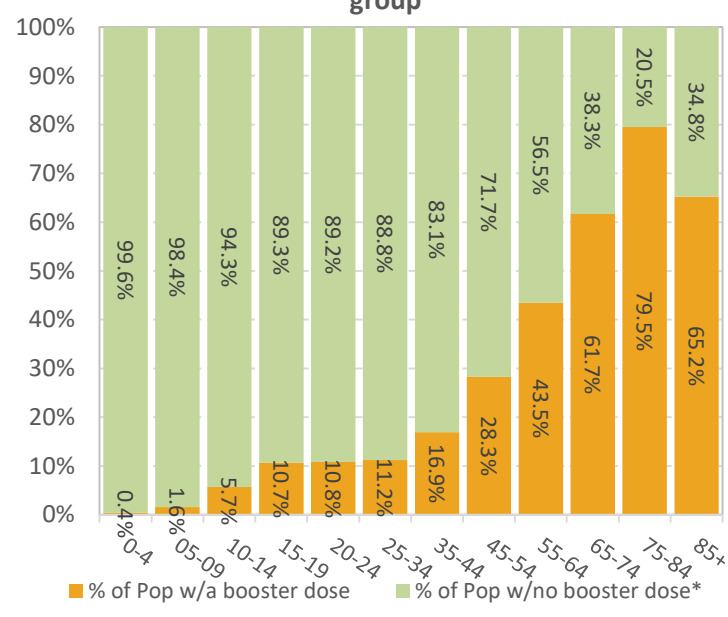

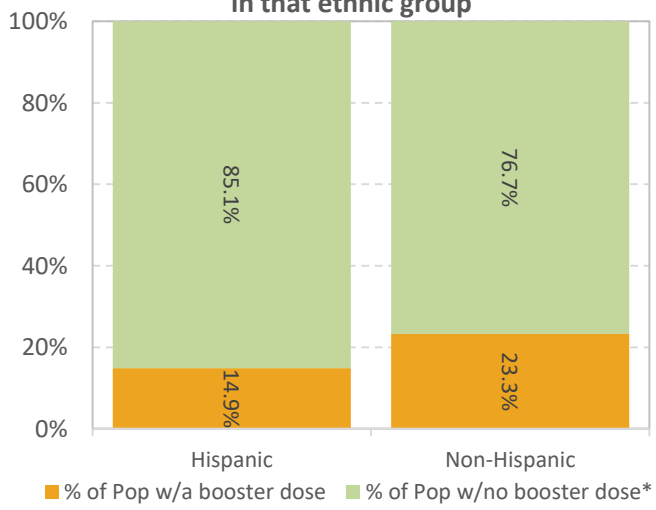
**% Newton residents who have received a booster dose by race out of all residents in that racial group**



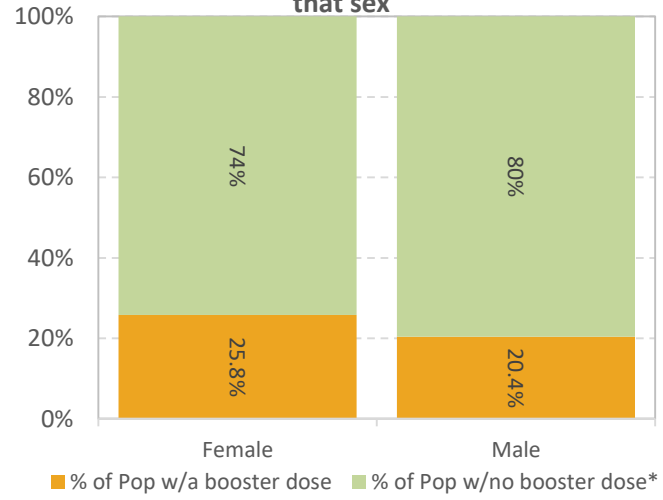
**% Newton residents who have received a booster dose by age group out of all residents in that age group**

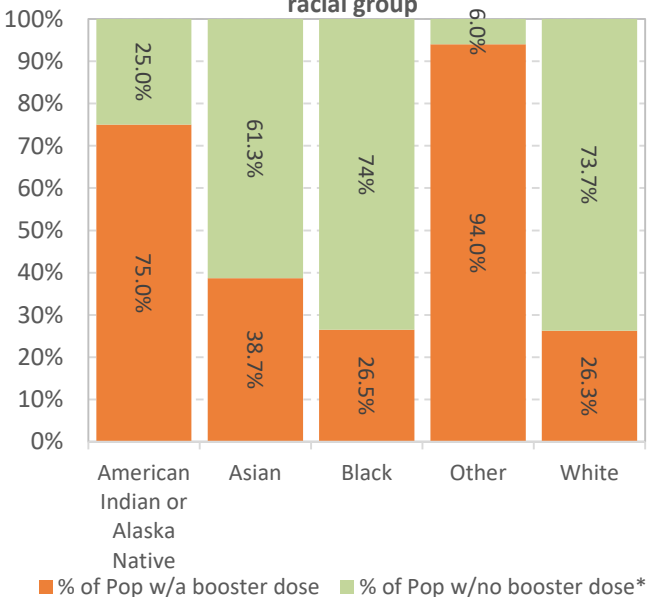

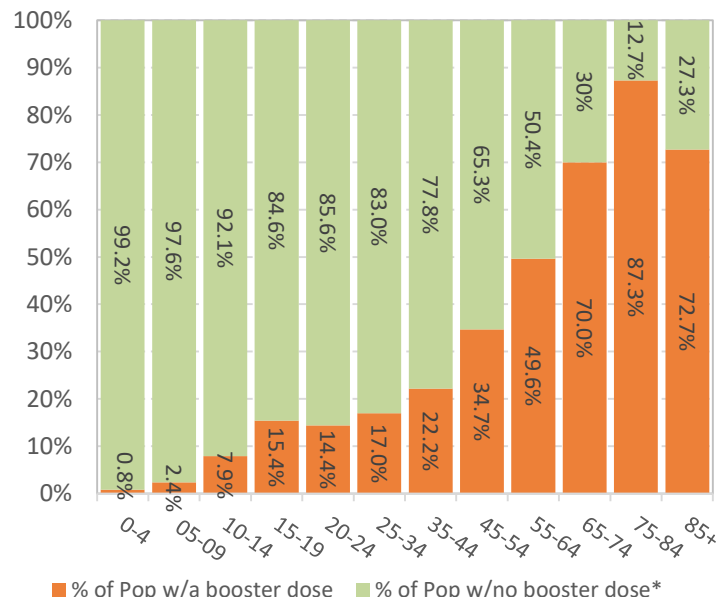

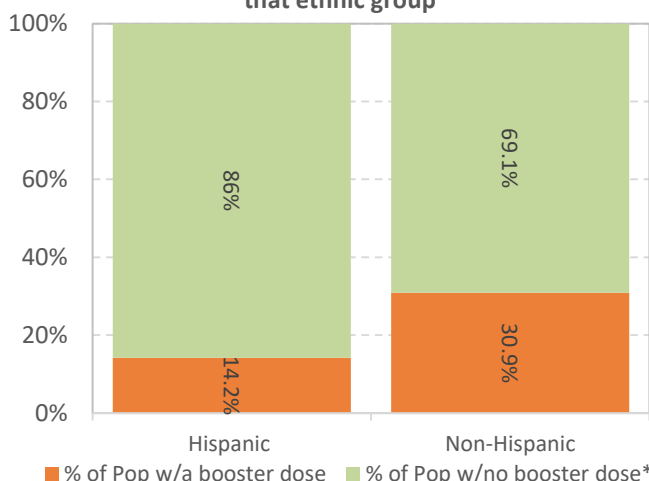
**% of Rockdale residents who have received a booster dose by race out of all residents in that racial group**
